THIS MATTER having been brought to the attention of the Court by Michael De Blis III, Esq., attorney for the plaintiff, ALICE KRAMDEN upon Notice of Motion; and Mark Gruber, Esq., of the law firm of Gruber, Colabella, Liuzza, Kutyla & Ullmann, attorneys for the defendant, RALPH KRAMDEN; and the Court having heard the arguments of counsel; and having read the papers submitted; and for good cause shown;

IT IS on this 23^{rd} day of June, 2007 **ORDERED** as follows:

- 1. The effective date of this Order is April 26, 2007.
- 2. The plaintiff is awarded joint legal custody of the unemancipated child, Trixie Kramden.
- 3. The plaintiff is granted primary residential custody of the unemancipated child, Trixie Kramden.

- 4. The defendant is directed to pay \$300.00 child support for Trixie Kramden, payable through the Probation Department in the county where the defendant resides, retroactive to the filing date of this motion on April 26, 2007.
- 5. The defendant is directed to maintain the medical, optical, hospital, major medial, dental, drug, and diagnostic insurance presently available through the defendant's employment for the benefit of Trixie Kramden.
- 6. The defendant is directed to pay 100% of all <u>unreimbursed</u> medical, optical, hospital, major medical, dental, drug, and diagnostic expenses for both the plaintiff and Trixie Kramden.
- 7. The defendant is directed to pay all daycare expenses for Trixie Kramden.
- 8. The defendant is directed to pay alimony to the plaintiff, payable through the Probation Department in the county in which the defendant resides. Alimony shall be taxable to the payee, deductible by the payor and shall terminate on the death of the payee or payor.
- 9. The defendant is directed to pay the mortgage, real estate taxes, and homeowner's insurance on the marital home located at 116 N. Plainfield Avenue, Brick Township, Ocean County, New Jersey.
- 10. The defendant is directed to maintain the present term life insurance available through Northwest Mutual Life in the minimum amount of \$100,000, designating the plaintiff and Trixie Kramden as irrevocable beneficiaries.
- 11. The defendant is directed to pay the following:
 - a. Automobile insurance for the 2004 Toyota Camry;
 - b. Auto repairs for the 2004 Toyota Camry;
 - c. Car loan to Ocean Credit Union for the 2004 Toyota Camry; and
 - d. All credit card indebtedness.
- 12. The defendant is restrained from encumbering, disposing, or otherwise dissipating any and all assets which are listed on the parties' case information statements, and any other assets which may be subject to equitable distribution.
- 13. The defendant is directed to advance the sum of \$5,000 counsel fees payable to Michael DeBlis III, Esq. within ten (10) days of the date of this Order as and for the plaintiff's retainer in this action.

- 14. The defendant is directed to pay to the plaintiff counsel fees in connection with this motion payable to Michael DeBlis III, Esq., counsel for the plaintiff, within ten (10) day of the date of this Order.
- 15. The defendant is directed to pay to the plaintiff \$500.00 for purpose of pension evaluation fees, payable within ten (10) days of the dates of this Order.
